In consideration of my child (children) being permitted to attend and participate in the above noted trip, I **and the other Releasing Parties (as defined below)** hereby release and waive, in full, any and all claims I and the other Releasing Parties have or may hereafter acquire, which have arisen or may arise as a result of my child’s (children’s) participation in any aspect of the trip indicated against the Shawnee Mission Northwest Band and Drill Team Boosters Organizations, its officers, agents, employees, volunteers and successors and Unified School District No. 512 (commonly known as the Shawnee Mission Public Schools), its officers, board members, employees, volunteers, agents, contractors and successors (**the foregoing, the “Released Parties”**).

I understand that my child(ren) will be exposed to a variety of circumstances during the course of said trip. I, along with the other Releasing Parties, agree to not hold the Released Parties liable for any loss or damages (including but not limited to personal injury, property damage and any other loss or damage incurred by reason of my child’s (children’s) participation in such trip).

I further understand that the Unified School District #512, its officers, board, employees, agents, volunteers, contractors, and/or successors are not sponsoring the subject travel, nor have they endorsed said trip, directly or indirectly. I have not relied on any representations of the District, officers, board, employees, agents, contracts or volunteers in deciding to allow my child (children) to participate in said trip. Although some adults accompanying my child on said trip may be regular employees of the District, I understand that such adults are not acting as employees of the District for purposes of their involvement with said trip.

I, my child(ren) and his/her/their other parent or guardian (collectively, the “Releasing Parties”) have discussed the trip and reviewed this matter prior to my signing of this release. The Releasing Parties have collectively agreed that, as respects the Released Parties, we assume all responsibility for any injury or damage that might occur during this trip and we are aware that we will be solely responsible for any personal injury, property loss, and any other loss or damage that might occur during this trip.

I understand that the trip is sponsored and conducted in whole as an activity of the Shawnee Mission Northwest Band and Drill Team Boosters Organizations. I understand that the insurance coverage or other resources of the District and the Shawnee Mission Northwest Band and Drill Team Boosters Organizations will not be available to satisfy any claims arising in the course of the trip. I understand that I should obtain insurance coverage for said trip on my own.

I, the undersigned, have read this release and understand all of its terms. I execute it voluntarily and with full knowledge of its provisions and on behalf of all Releasing Parties. This release shall bind me, the other Releasing Parties, and our respective heirs, trustees, agents and assigns.
